

## Release of Liability and Assumption of Risk

In consideration of the services of **G-Force Laser Tag, Corp. dba G-Force Adventure, its operators, employees, volunteers, officers and it's agents** I agree to release, hold harmless and indemnify **G-Force Laser Tag, Corp. dba G-Force Adventure, its operators, employees, volunteers, officers and it's agents**, on behalf of myself and family members, partners, heirs, and assigns as follows:

- 1) I acknowledge that all activities and services including Laser Tag, Archery Tag, ReBall, Arcade entails risks that could result in physical or emotional injury, paralysis, death, seizures, coma, or any other injury to me, to property, or to third parties. I understand that the risks cannot be eliminated without jeopardizing the essential qualities of the activity or service. The risks could result in musculoskeletal injuries, including head, neck, elbows, knees, ankles and back injuries.
- 2) I accept and assume all the risks of being an observer or participation in all activities and services. My participation or observing of all activities and services are purely voluntary, and I elect to participate in spite of the risks. I agree that any pre-existing conditions as head, back, neck, leg, arm injuries will not permit me to participate in any activities or services provided by **G-Force Laser Tag, Corp. dba G-Force Adventure, its operators, employees, volunteers, officers and it's agents**. The attendants/operators are not responsible for determining the physical condition or ability of any participant.
- 3) I release and agree to indemnify and hold harmless **G-Force Laser Tag, Corp. dba G-Force Adventure, its operators, employees, volunteers, officers and it's agents** from any claims that are in any way connected with my by standing or participation with any activity or service or use of **G-Force Laser Tag, Corp. dba G-Force Adventure** equipment, service or facilities, including claims that **G-Force Laser Tag, Corp. dba G-Force Adventure, it's operators, employees, volunteers, officers and it's agents** were negligent.
- 4) I have adequate insurance to cover any injury or damage I may cause or suffer while being an observer or participating and agree to bear the cost of any injury or damage.
- 5) I agree that if any portion of this agreement is found to be void or unenforceable, the remaining portions shall remain in full force and effect.
